MINUTES

OF THE

SHAKOPEE PUBLIC UTILITIES COMMISSION (Regular Meeting)

President Joos called the regular session of the Shakopee Public Utilities Commission to order at the Shakopee Public Utilities meeting room at 5:00 P.M., March 6, 2017.

MEMBERS PRESENT: Commissioners Joos, Olson and Weyer. Also present, Liaison Whiting, Utilities Manager Crooks, Finance Director Schmid, Planning & Engineering Director Adams, Line Superintendent Drent and Water Superintendent Schemel. Commissioners Amundson and Helkamp were absent as previously advised.

Motion by Olson, seconded by Weyer to approve the minutes of the February 21, 2017 Commission meeting. Motion carried.

There were no Communication items to report.

President Joos offered the agenda for approval.

Motion by Weyer, seconded by Olson to approve the agenda as presented. Motion carried.

Motion by Olson, seconded by Weyer to approve the Consent Business agenda as presented. Motion carried.

President Joos stated that the Consent Item was: Item 11a: January Financial Results.

The warrant listing for bills paid March 6, 2017 was presented.

Motion by Weyer, seconded by Olson to approve the warrant listing dated March 6, 2017 as presented. Motion carried.

Liaison Whiting presented his report. Several City Council agenda items were discussed. Items included were the CR 78/CR79 Trail Agreement, the Whispering Oaks Sewer project, the 2017 Street Reconstruction Project and utility relocations on CR 78 and CR 79.

Water Superintendent Schemel provided a report of current water operations. Upgrades with T Mobile and Verizon were discussed. The Department attended hazardous chemical training. Maintenance work continues with the Pumphouses.

Line Superintendent Drent provided a report of current electric operations. Three separate electric outages were reviewed. One outage affected 17 customers, one affected 2 customers and the third outage affected a single customer. Due diligence continues with the SCADA bid review process.

Mr. Drent updated the Commission on the Shakopee Energy Park (SEP) and Dean Lake Substation projects. SEP began commercial operation on February 15.

Planning and Engineering Director Adams reviewed the Shakopee Avenue overhead electric facilities. With the 2017 Street Reconstruction Project, there is an opportunity to relocate the existing power lines that are in residential backyards, with limited access.

Motion by Weyer, seconded by Olson to accept the preliminary engineering report and adopt a position to approve the recommendation to relocate the overhead electric facilities underground with the funding sources as outlined in the report. Motion carried.

Motion by Olson, seconded by Weyer requesting Staff to create and circulate a petition to the affected property owners to initiate a public improvement project and submit said petition to the City for review and action. Motion carried.

Item 11a: January Financial Results were received under Consent Business.

Under New Business, Commissioner Olson presented Mr. Crooks with a Shakopee Valley News newspaper from 1967. In the paper there is an article about a City Council, Utilities accord that was tentatively reached regarding City Payments.

The tentative commission meeting dates of March 20 and April 3 were noted.

ISSUE

On October 7, 2002 the Commission adopted the enclosed Resolution #697 A Resolution Designating the Terms Under Which Water is Made Available to a Portion of Lot 1, Block 1 Superior Supply First Addition and Resolution #698 A Resolution Setting the Amount of the Trunk Water Charge, Approving of Its Collection and Authorizing Water Service to Certain Property Described as: A Portion of Lot 1. Block 1 Superior Supply First Addition.

BACKGROUND

As an outcome of the city project to install a public water main across CR 21 and along Stagecoach Road to loop the Southbridge PUD residential area and supply a second source of water, in 2002 Cherne Company requested water service to their building from the new water main running alongside their property. Due to the uncertainty of what might if ever develop on the balance of their property, uncertainty due to the fact it was surrounded on all sides by public right of way including the Highway 169 Bypass and the CR 101 Ramps, Cherne asked the Commission to defer the potential requirement to install additional public water main until such time that the balance of their property was either subdivided or not when further development would occur. Thus, the terms of water service were included in the agreement attached to Resolution #697. Cherne also requested at that time to only pay for the Trunk Water Charge against a portion of the parcel, deferring the balance until such time further development occurred and the Commission agreed.

DISCUSSION

The new owners of the property, Stagecoach Real Estates Holding LLC and their principal Mr. Doug Schieffer, have recently submitted plans to construct a second building on the parcel under a CUP without subdividing, thus eliminating the need for additional public water main.



While researching the files to determine what additional requirements might apply, staff has determined that a Trunk Water Charge to be applied to the balance of the parcel is in order and a resolution for the same has been prepared for the Commission's consideration.

However, staff also discovered that in the official records of the Commission's resolutions that an intended and referenced attachment to Resolution #697 was apparently omitted at the time of its adoption. That attachment, labeled Exhibit A, is the legal description of only a portion of the parcel defining the area roughly occupied by the existing building on the site back in 2002 and encompasses the 4.60 acres that the Trunk Water Charge was collected against then. The actual attachment found was the Agreement to Complete Water System which agreement has its own unique Exhibit A which was the legal description of the area that the Trunk Water Charge was not being collected against at that time per Cherne's request. Hence, without some further action some confusion could result on which portion of the parcel the Commission intended to grant water service to in 2002 and which portion of the parcel the Commission intended to designate needing further requirements including additional Trunk Water Charges to be collected at a future date.

Staff is recommending the Commission amend Resolution #697 to include the correct Exhibit A as originally intended to clarify the record, while also adopting the Trunk Water Charge for the balance of the parcel under discussion.

REQUESTED ACTION

Staff requests the Commission adopt Resolution #1159 A Resolution Amending Resolution #697 and Setting the Amount of the Trunk Water Charge, Approving of Its Collection and Authorizing Water Service to Certain Property Described as: The Balance of Lot 1, Block 1 Superior Supply First Addition.

AGREEMENT TO COMPLETE WATER SYSTEM

Agreement between Shakopee Public Utilities Commission (Commission), and Cherne Contracting, Inc. (Developer).

This agreement encumbers property as described in Exhibit "A' attached hereto.

Developer has requested city water be extended to serve property described as:

That part of Lot 1, Block 1, SUPERIOR SUPPLY FIRST ADDITION, according to the recorded plat thereof, Scott County, Minnesota, which lies westerly of a line described as commencing at the northwest corner of said Lot 1; thence North 74 degrees 44 minutes 02 seconds East, assumed bearing, along the north line of said Lot 1 a distance of 280.23 feet, thence South 0 degrees 20 minutes 16 seconds West, a distance of 51.75 feet, thence North 74 degrees 44 minutes 02 seconds East, assumed bearing, along the north line of said Lot 1 a distance of 297.50 feet to the point of beginning of the said line to be described; thence deflecting 90 degrees 0 minutes 0 seconds to the right a distance of 576.66 feet to the south line of said Lot 1 and said line there terminating.

Due to the undetermined future development of the property described in Exhibit "A" of this agreement, and due to the desire of Developer to secure city water service to the property described above, Developer requests approval of: an incomplete watermain distribution system to serve the property described above for which he has requested water service; and agrees to construct additional watermain and appurtenances and to make additional Trunk Water Charge payments in the future as such time that all or part of the property described in Exhibit "A" is developed or utilized in any way except farmland. The property described in Exhibit "A" does not now have, and will not have city water available until the construction of additional watermain and appurtenances and payment of additional Trunk Water Charges.

Developer agrees to construct said additional watermain and appurtenances in accordance with Commission standard policies and specific requirements at the sole cost and expense of the Developer. Developer further agrees the additional Trunk Water Charges shall be calculated in accordance with the rate in effect at the time water service is made available.

Standard policies shall be those which are in effect at the time of actual construction of the future watermain. Specific Commission requirements are as described on Exhibit "B" to this agreement.

This agreement shall be filed with Scott County Recorder, it shall be binding on heirs successors and assigns and shall continue in force until terminated by mutual agreement between Developer and Commission.

Developer covenants that it is in agreement with the above statements is the owner of the lands described in Exhibit "A" and further covenants that the said lands are free and clear of all encumbrances and liens except the following:



SCADA Bid Award

Overview:

We opened bids on February 14th for a new SCADA system; the bids tabulation sheet and Engineer recommendation are attached.

Our current SCADA system is called C3ilex and it is old, outdated and an unsupported SCADA system. We have had many problems with the current system and we haven't been able to add our most recent projects on that SCADA system. We can't see some of our feeder amperages, load profile, breaker status unless we go to substations and view the data there. This is very inefficient and when the linemen are working on some lines they have to go to that substation and set some controls before working on the line.

Discussion:

In the 2017 CIP budget we allocated \$205,000.00 for a new SCADA system. The low bid was Survalent Technology, Inc. in the amount of \$175,128.63 for the project. There is also an alternate bid of \$48,620.47 for an additional five years of support. The alternate bid will be part of the 2018 budget. We are pleased with Survalent SCADA system and we viewed two different municipal utilities that have converted from C3ilex SCADA system to Survalent SCADA system in Marshall, MN and Waverly, IA. These utilities are very pleased with Survalent system and the implementation process went according to plans and specs.

With the new system we will be able to view loads at the control room, operate all substation breakers, switch loads to different feeders during outages, load control and get text messages /emails of breaker operation, hot line tag to name a few things. Some outages could be a little shorter as the system gives distances to the fault if a substation breaker has an operation. We are excited to get a new system that is supported and has up to date technology. Survalent is also capable of adding modules to their platform in the future if we want to add OMS (Outage Management System) or AMI (Advanced Metering Infrastructure).

Recommendation:

Staff recommends the commission award Survalent Technology, Inc. the bid for a new SCADA system for the amount of \$175,128.63.

We have completed our review and subsequent follow-up work regarding the bids that were received on February 14, 2017 for the furnishing of a SCADA system for Shakopee Public Utilities (SPU). A bid summary form is included which shows a tabulation of the bids. We will send a copy of the bid summary to the bidders.

The evaluated low bid meeting the specifications was submitted by Survalent Technology, Inc. in the amount of \$175,128.63, including sales tax. Their proposed schedule satisfies the SCADA cutover timeframe and they have successfully demonstrated their system capabilities. We have worked with Survalent on past projects and know of no reasons why they would not perform well on this project. We therefore recommend awarding the project to Survalent Technology, Inc. based on their bid of \$175,128.63 for this project.

Survalent included an alternate bid item A1, totaling \$48,620.47, to provide five additional years of software support and maintenance beyond the one-year requirement included in the specifications (total of six years). Whether by accepting alternate bid item #1 at this time or by contracting for these services at a later date, we recommend that SPU act upon extending the service plan before the base bid software support and maintenance plan expires.
